PROPOSED WORKS:

Re-ordering and refurbishment to include the addition of a double height extension to the Church Room on the south elevation. To allow provision for more flexible worship and office space, the works to allow for new first floor office and welcome area, meeting rooms on mezzanine level across the west end, and provision of new toilet and kitchen facilities.

These works will involve removal of most internal furniture and the introduction of 150 chairs, this is detailed in the document dated April 2019, prepared by Brian Gaffney "Description of wood items to be removed - retained". Also the works are to include the relocation of the font to the north porch, removal of Lady Chapel Altar, introduction of new heating, lighting and audio visual equipment, new glazed entrance doors, the levelling of floor in wood across the worship space, and the relocation of 10 commandments plaques on the west end wall.

Exterior works to include widening and resurfacing of the main entrance path and introduction of better lighting, the removal of two cherry and one yew trees, the relocation of some memorial stones and possible relocation of some burial remains during the excavation for the new extension as detailed in document Graves - The Church of the Holy Saviour, dated 15th May 2017. All works are to be in accordance with the Design and Access Statement by Studio Four Architects Ltd dated 31/01/2018 A and associated plans and drawings numbered 32129 - 0A, 01B, 28, 32T, 45, 46A, 51B 90A, 91C, 104, 105J, 06E, 108, 09, 110C, 111C, 115C, 116A, 117, 120C, 122B, 125C, 129A, provided by Gareth Jenkins of Studio Four Architects Ltd.

A PETITION has been submitted to the Court in respect of the proposed works detailed above, which fall within the categories of proposed works required by the Faculty Jurisdiction Rules 2015 to be notified by publication on the Diocesan Website.
